About this project

This project is a masters project in the School of Psychology at the University of Nottingham.

The project is looking for individuals over the age of 18 years old. The project is exploring

individual's responses to various bodily fluids such as saliva, semen, and breastmilk to better

understand how disgust sensitivity varies across different contexts. This research will build on

existing work measuring general disgust, while addressing the current lack of a scale that

specifically measures disgust towards bodily fluids. The study will also examine how

responses differ depending on whether the fluid is perceived as one's own, a family member,

or a stranger.

What do I have to do?

Throughout the survey, you will be asked to complete a variety of questions. For instance,

some questions will be multiple-choice, and other statements will ask you to expand on your

answer so that we can understand your response fully. Throughout the survey, instructions

will be provided to you. It should take approximately 12 minutes. Please answer the questions

in the questionnaire. However, you do not have to answer any questions if you do not wish

to do so, and you can do this by leaving the box blank.

Do I have to take part?

You can decide whether you participate or not. If you choose to take part, you will be able to

keep a copy of this information sheet by emailing one of the researchers. You will be able to

indicate your agreement to the online consent form. You can withdraw at any time during the

survey by closing the browser, and without providing a reason to us. It is important to note

that once you finish the survey and press submit, you will not be able to withdraw your data.

You have the right to refuse to answer any questions you do not feel comfortable answering.

What are the possible benefits of taking part?

We believe that by taking part in this research you will provide the field with new and relevant

literature that could potentially be used in future research.

What are the possible disadvantages and risks of taking part?
