How the University of Nottingham processes your personal data

- All lessons will be taught by a qualified Level 2 swimming instructor and the 1. University reserves the right to use cover instructors as required.
- 2. Lesson will be 25 minutes long (55 minutes for extended 1-2-1s) including registers and any set-ups for the lessons.
- 3. The competitive pool's temperature (Junior and Adult group lessons and 1-2-1 lessons) water temperature is maintained at 27.5 $^{\circ}$ C; the Hydrotherapy pool's temperature is maintained at 32 °C.

- We recommend that swimmers should wear either a swimming costume or swimming trunks. Swim shorts and bikinis are not advised as they will hinder your child's ability to progress their swimming. Children who are not confidently toilet trained must wear a swim nappy and a swimming costume over the top of the
- No jewellery should be worn during swimming lessons with the exception of stud earrings and long hair must be tied back.

Health and safety

- It is the swimmers' or parent/carer's (for under 18's) responsibility to notify us of any illnesses, injuries or medical conditions; and this will be assumed to be accurate. Should this not be the case, we will not accept liability for any incidents caused as a consequence.
- 7. If your child has been ill within 48 hours of the class taking place, they must not participate for their own health and safety.
- If you are presenting Covid-19 symptoms then please do not attend your lesson. 8
- 9. Swimmers are advised to not eat or be breastfed at least an hour before they swim.

Booking, payment and cancellations

- To guarantee your place on any Swim School programme payment must be made upfront either over the phone or at reception.
- Once you have booked and paid, we have a no refund policy in operation unless there 11. are exceptional circumstances.
- Refunds and credits will not be provided for illnesses, including confirmed Covid-19 cases, suspected Covid-19 symptoms and isolating due to Covid-19 exposure
- 13. All information supplied to University of Nottingham Sport, e.g. swimming ability or medical details, will be assumed to be true and accurate.
- If University of Nottingham of Sport has to cancel a lesson due to exceptional circumstances, you will be notified and a credit will be applied to your account.
- 15. University of Nottingham Sport reserves the right to amend the Swim School programme or to cancel lessons if there are insufficient numbers within a particular

Photography

- Photography and filming are strictly prohibited within the facility. The use of mobile phones is not permitted within the changing areas or on poolside.
- The University of Nottingham may take photographs of swimming lesson participants for marketing purposes. If this is the case you will be notified in advance and it is the responsibility of the parents/guardian to provide consent for you/your child to be photographed. This consent may be withdrawn at any time in line with the 2018 General Data Protection Regulations (GDPR).

Parental supervision

- For Early Years lessons, one responsible adult must accompany the participating child in the water.
- 19 It is the parent/carer's responsibility to maintain their children's safety prior to and after their lesson.
- For any swimmer under the age of 8 years, the parent or carer must remain within the swimming lesson waiting area.
- 21. Access onto poolside is not permitted during the lesson for parents or carers.

Use and Redemption of Financial Credits

All financial credits will be retained for a period of 6 months and can be redeemed against activities or goods sold or offered by the University Sports Department up to the full value of the credit at any time throughout that period. Credits will be removed from member accounts 6 months from the date of award and are not redeemable after this time

Conduct

- 23 All members will be held accountable for their behaviour
- 24. Disorderly, rude or offensive behaviour may result in refusal of entry into UoN Sports Facilities and will constitute a serious breach of these terms and conditions.
- Members must use all facilities and equipment in accordance with advice given by employees of the UoN Sport Department and notices suitably posted throughout the buildings. Members shall not abuse the equipment or facilities of the University.
- No member shall bring intoxicating liquor into the facilities, anyone appearing to be under the influence of alcohol and/or drugs will be asked to leave the facility. 26
- 27 Smoking is not permitted within the UoN Sports Facilities.
- Members use the facilities at their own risk; UoN does not accept responsibility for any harm or injury to any customer unless caused by negligence of UoN management, employees or agents.
- Any damage to UoN property shall be paid for in full by any member who wilfully or 29. negligently causes such damage.
- Cars parked on the UoN campus are left at the owner's risk. UoN will accept no liability for loss or damage thereof unless caused by the negligence of employees or

Epidemic or Pandemic

- The health and wellbeing of our members, visitors and staff is taken very seriously.
